A BILL

To require a full audit of the Board of Governors of the Federal Reserve System and the Federal reserve banks by the Comptroller General of the United States, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Federal Reserve Trans-*
5 *parency Act of 2014”.*

6 **SEC. 2. AUDIT REFORM AND TRANSPARENCY FOR THE**
7 **BOARD OF GOVERNORS OF THE FEDERAL RE-**
8 **SERVE SYSTEM.**

9 *(a) IN GENERAL.—Notwithstanding section 714 of title*
10 *31, United States Code, or any other provision of law, the*
11 *Comptroller General shall complete an audit of the Board*
12 *of Governors of the Federal Reserve System and the Federal*
13 *reserve banks under subsection (b) of such section 714 with-*
14 *in 12 months after the date of the enactment of this Act.*

15 *(b) REPORT.—*

16 *(1) IN GENERAL.—Not later than 90 days after*
17 *the audit required pursuant to subsection (a) is com-*
18 *pleted, the Comptroller General—*

19 *(A) shall submit to Congress a report on*
20 *such audit; and*

21 *(B) shall make such report available to the*
22 *Speaker of the House, the majority and minority*
23 *leaders of the House of Representatives, the ma-*
24 *jority and minority leaders of the Senate, the*
25 *Chairman and Ranking Member of the com-*

1 *mittee and each subcommittee of jurisdiction in*
2 *the House of Representatives and the Senate, and*
3 *any other Member of Congress who requests the*
4 *report.*

5 (2) *CONTENTS.—The report under paragraph (1)*
6 *shall include a detailed description of the findings*
7 *and conclusion of the Comptroller General with re-*
8 *spect to the audit that is the subject of the report, to-*
9 *gether with such recommendations for legislative or*
10 *administrative action as the Comptroller General*
11 *may determine to be appropriate.*

12 (c) *REPEAL OF CERTAIN LIMITATIONS.—Subsection*
13 *(b) of section 714 of title 31, United States Code, is amend-*
14 *ed by striking the second sentence.*

15 (d) *TECHNICAL AND CONFORMING AMENDMENTS.—*
